2. The board reviewed the minutes of the August 26, 2022 board meeting.

Mike Rosamond moved and Graham Irvine seconded approval of the minutes as presented: motion passed.

3. Flock Safety Presentation

- DPD officers presented information about the Flock camera system, which can be leased by municipalities, HOAs, PIDs, etc. and work in coordination with local law enforcement to identify and track "hot listed" vehicles to help catch criminals.
- Both PIDs have money in the budget to lease cameras.

4. Board Member Elections:

- Dorinda reported that current board members Tommy Bailey, Allison Griffin, Dawn Waye -- have terms expiring September 30 and that each has agreed to serve another three-year term, if duly elected by the board. Mike moved to re-elect the three members for another three-year term beginning October 1, 2022; Graham seconded the motion. The motion was approved.
- Allison Griffin moved to elect Michelle Pitsenberger to a new board term to replace Amrit Chase for a new threeyear term beginning October 1, 2022. Dawn Waye seconded the motion. The motion was approved.
