Mike Rosamond moved that the Lake Highlands Public Improvement District (LHPID) fund the preparation of design and construction documents by Kimley Horn, up to the budgeted amount of \$119,900, for streetscape improvements in the medians and behind the curbs of Skillman Street between Church Road and Sedgwick Drive, as part of the Skillman Corridor Master Plan. Rowland Jackson seconded the motion. The Landscape Committee voted unanimously to bring the recommendation forward to the LHIDC board of directors.

Discussion on the overall scope of the project. A question regarding the survey cost was discussed by the group. Another question regarding the oversight of construction - City of Dallas will oversee construction. The PID will be involved to ensure the design and construction adheres to the approved construction plan.
